2. Bids received in excess of the ABC shall automatically be rejected at Bid Opening.
3. PITC and RITM now invite bids from authorized Philippine dealers, distributors, or resellers for the Supply, Delivery, and Installation of Three (3) Units Brand New Elisa Reader, Four (4) Units Brand New Elisa Washer/Dispenser, and Two (2) Units Brand New Fully Automated Elisa Workstation (hereafter referred to as GOODS).
4. A prospective Bidder must have completed a Single contract of similar nature within last five (5) years amounting to at least fifty percent (50%) of the ABC of the item being bid.  
**Similar contract shall mean "Laboratory Equipment".**
5. **Delivery / Completion Period:** Within **Sixty (60)** calendar days upon receipt of Notice to Proceed (NTP).
6. **Delivery Place:** Materials Management Department (MMD) Delivery Area, Research Institute of Tropical Medicine, 9002 Research Drive, Filinvest Corporate City, Alabang, Muntinlupa City 1781

7. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by **R.A. 9184** and its **2016** Revised IRR.
8. The Invitation to Bid and Bidding Documents may be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and PITC website at **www.pitc.gov.ph**. Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00am – 4:00pm) on weekdays only.
9. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am – 4:00pm) but not later than 4:00pm upon payment of a non-refundable fee as indicated above. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

It may also be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
