The **Philippine International Trading Corporation (PITC)** and the **University of the Philippines, Diliman** intend to apply the sum **PESOS: Nineteen Million Two Hundred Ninety Seven Thousand Five Hundred Sixty Eight and 51/100 (P19,297,568.51)** being the Approved Budget for the Contract (ABC) to payment for the **Supply, Delivery, Installation, Testing and Commissioning of Swimming Pool Equipment and Accessories for University of the Philippines – Diliman (UP-Diliman)**

2. Bids received in excess of the ABC shall automatically be rejected at Bid opening.
3. PITC and UP Diliman now invite Bids from authorized Importers/ Suppliers/ Resellers/Distributors/Dealers for the Supply, Delivery, Installation, Testing and Commissioning of Swimming Pool Equipment and Accessories for UP Diliman.
4. The bidding is restricted to Filipino citizens / sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging citizens of the Philippines.
5. A prospective Bidder must have completed a single largest contract of similar nature within last **five (5) years** amounting to at least **fifty percent (50%)** of the ABC of the Swimming Pool Equipment.
Similar contract shall mean “**Swimming Pool Equipment and Accessories**”.
6. **Delivery and Installation Period:** One Hundred Eighty (180) calendar days from the date of receipt of the Notice to Proceed.
7. **Installation Site:** Swimming Stadium, College of Human Kinetics, University of the Philippines, Diliman, Quezon City
8. Open competitive bidding procedures will be conducted using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the “Government Procurement Reform Act”. All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its **2016** Revised IRR.
9. The Invitation to Bid and Bidding Documents may be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and PITC website at www.pitc.gov.ph. Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00am – 4:00pm) on weekdays only.
10. The complete set of Bidding Documents may be acquired by interested bidders during office hours (8:00am – 4:00pm) but not later than 4:00pm upon payment of a non-refundable fee as indicated above. The Bidding Documents shall be received personally by the prospective

Bidder or his duly authorized representative upon presentation of proper identification document.

It may also be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
