This **Supplemental Bid Bulletin No. 1** is being issued in response to the request for clarification from Philippine Chemsteel Industries, Inc. per letter dated 09 July 2019 for the information of all prospective bidders.

SUBMISSION AND OPENING OF BIDS: 24 JULY 2019, 9:00AM

Query:	<p>On the previous opening of Bids of the abovementioned project we were disqualified because not all pages of our Audited Financial Statement (AFS) were stamped by the RDO where we filed our FS. Our personnel responsible for filling the FS went back to RDO 28 in Novaliches and went to ask for the particular BIR officer who stamped and signed our AFS. Our personnel then asked the BIR officer to have the additional stamps on our AFS and stated the case that our AFS failed to meet the required stamps during the bidding. Instead of stamping the BIR officer furnished him a copy of a BIR Circular/Memorandum of certain pages to be stamped by their office.</p> <p>We are writing this letter to have you informed of the BIR position and to have the matter straightened regarding the validity, legality and acceptability and compliance of our AFS. Please take note also that we have submitted the same AFS to the PHILGEPS for our updated PHILGEPS Certificate and we were not questioned about it.</p>
Response:	<p>The letter of Philippine Chemsteel Industries, Inc. is duly noted.</p> <p>The Committee takes this opportunity to clarify that the requirement under Clause 12.1 of the Bid Data Sheet remains as this is consistent with the existing issuances of the Bureau of Internal Revenue.</p> <p>However, as manifested by Philippine Chemsteel Industries, Inc. that it has already updated its documents with the PhilGEPS for its Platinum Membership, then it may opt to submit its valid and current Certificate of PhilGEPS Registration (Platinum Membership) in lieu of the mandatory four (4) Eligibility Documents for bid opening purposes.</p>

This Supplemental Bid Bulletin No. 1 shall form part of the Bidding Documents. Any provisions in the Bidding Documents inconsistent herewith is hereby amended, modified and superseded accordingly.
