- The **Philippine International Trading Corporation (PITC)** and the **Philippine Navy (PN)**, intend to apply the sum of Pesos: **Five Million Three Hundred Three Thousand Two Hundred Twenty Seven and 66/100 (₱ 5,303,227.66)**, being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply of Labor and Materials for Installation of Streetlights at NSPL & NBHA and Rehabilitation of Commodore Posadas Wharf Shore Power System of the Philippine Navy (PN) – One (1) Lot**.

- Bids received in excess of the ABC shall be automatically rejected at bid opening.
- PITC and PN now invite Contractors with valid and current Philippine Contractors Accreditation Board (PCAB) License with Classification / Category in General Building / General Engineering, with Minimum Size Range of Small B and Minimum License Category of C or D with **specialty in Electrical Works (SP-EE)** to bid for the **Supply of Labor and Materials for Installation of Streetlights at NSPL & NBHA and Rehabilitation of Commodore Posadas Wharf Shore Power System of the Philippine Navy (PN) – One (1) Lot**, (hereinafter referred to as the "WORKS"). The PCAB license must indicate "PCAB registered contractor for Government Projects."
- The bidding is open to Filipino citizens / sole proprietorships, partnerships, or organization with at least sixty percent (60%) interest or outstanding capital stock belonging citizens of the Philippines.
- Prospective Bidders should have completed a single contract similar to the Project amounting to at least fifty percent (50%) of the ABC adjusted to current prices using the National Statistics Office consumer price index.  
For purposes of this project, "similar contract" shall refer to contract involving **electrical works**.
- Project Completion Period is within **Sixty (60) calendar days** upon receipt of the Notice of Site Possession.

7. Open competitive bidding will be conducted using non-discretionary pass/fail criterion as specified in the Revised Implementing Rules and Regulations (Revised IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act." All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post Qualification procedures and Award of Contract shall be governed by R.A. 9184 and its Revised 2016 IRR.
8. The Invitation to Bid and Bidding Documents may be downloaded from the website of the **Philippine Government Electronic Procurement System (PhilGEPS)** and **PITC website** at [www.pitc.gov.ph](http://www.pitc.gov.ph). Interested bidders may inspect the Bidding Documents upon presentation of proper identification during office hours (8:00AM – 4:00PM) on weekdays only.
9. The complete set of Bidding Documents maybe acquired by interested bidders during office hours (8:00am – 4:00pm) but no later than 4:00pm upon payment of a non-refundable fee as indicated above. The Bidding Documents shall be received personally by the prospective bidder or his duly authorized representative upon presentation of proper identification document.

It may also be downloaded free of charge from the website of the PhilGEPS and the PITC website, PROVIDED that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

However, bidders who previously bought Bidding Documents under previous Bid Ref. No. MPG-B2-2018-406 and Bid Ref. No. MPG-B2-2018-609 Rebid may acquire Bidding Documents free of charge upon presentation of the Official Receipt.

For the Pre-bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the Bidding Documents.
